Recreation Commercial / Office = 50sf Commercial- C-1 / C-2 = 160sf Industrial – I-1 / I-2 = 160sf

- ♦ Setbacks: 10ft from ROW - 20ft from property line - 50ft from residential
- ♦ Setback from building: 2 ft horizontal & 6 ft vertical separation – no attachment to building
- ♦ Street address shall be clearly displayed in six (6) inch letters
