SEWER FEE/RATE SCHEDULE

Effective 1st Quarter 2024

Section 34-184 (a) CONNECTION FEES

A. Direct Connection

1. For each direct connection to lines of the Sewer System, there shall be charged a fee of \$2,350.00 multiplied by the REU of the user if the premises are connected to the Sewer System.
2. Each user whose premises are connected to the Sewer System after June 1, 2005, shall pay the direct connection fee of \$2,375.00 per REU. An additional \$25.00 per REU will be added annually every June 2nd thereafter.

B. In-Direct Connection

1. In order to defray the proportional share of the necessary over sizing of trunks and pumping stations, for each indirect connection to the Sewer System there shall be charged a fee of \$1,175.00 multiplied by the REU of the user if the premises are connected to the Sewer System.
2. Each user whose premises are connected to the Sewer System after June 1, 2005, shall pay the indirect connection fee of \$1,187.50 per REU. An additional \$12.50 per REU will be added annually every June 2nd thereafter.

C. Sewer Inspection fee will be \$70.00 per inspection.

Section 34-185 (a) SEWER USE CHARGES

METERED – Water Use

The sewer use charge shall be the metered water consumption, or 20 hundred cubic feet of water multiplied by the REU, whichever is greater, multiplied by the rate of \$3.35 per 100 cubic feet of water.

UNMETERED - Water Use

The sewer use charge shall be 30 hundred cubic feet of water multiplied by the rate of \$3.35.

Section 34-185 (c) SEWER USE CHARGES

- (1) \$.209 per pound of B.O.D.;
- (2) \$.161 per pound of suspended solids;
- (3) \$.055 per thousand gallons of flow;
- (4) \$1.5485 per pound of phosphorus.

Section 34-185 (d) SEWER USE CHARGES

A quarterly use charge of \$36.90.
A quarterly debt charge of \$16.50.

Section 34-185 (e) SEWER USE CHARGES

One Time Delinquent Account Charge of \$50 for services as established by the Bay County Department of Water and Sewer.

Section 34-186 (a) INDUSTRIAL COST RECOVERY

1. For the Wastewater Treatment Plant
 - a) 1.66 cents per pound of five (5) day B.O.D.;
 - b) 0.89 cents per pound of suspended solid;
 - c) 0.38 cents per pound of phosphorus;
 - d) 6.39 cents per 1,000 gallons; and
2. For Interceptors
 - a) with equalized pretreatment – 3.59 cents per 1,000 gallons;
 - b) without equalized pretreatment – 13.4 cents per 1,000 gallons;
3. For collectors constructed after March 1, 1978
 - a) with equalized pretreatment – 5 cents per 1,000 gallons;
 - b) without equalized pretreatment – 21 cents per 1,000 gallons;

4. All industrial users paying said ICR charges shall be entitled to an annual domestic wastewater allowance for each employee of such industry as follows:
 - a) 7.8 pounds per year of five (5) day B.O.D.;
 - b) 9.5 pounds per year of suspended solid;
 - c) .3 pounds per year of phosphorus;
 - d) 4,420 gallons per year.

Section 34-217 (d) PRETREATMENT

1. \$.209 per pound of B.O.D.;
2. \$.161 per pound of suspended solids;
3. \$1.5485 per pound of phosphorus.
