Roofing - When you tear off to the deck you must: install ice guard on all over hangs extending up past the exterior wall by two feet and install ice guard in all valleys.  
 Doors - If changing the opening and header, it must be inspected before covering up.  
 Windows - If the openings are changed, they must be inspected before covering up. If bedroom openings are enlarged, they must meet egress requirements.

I certify that I am the owner or authorized by the owner to make this application for the proposed work. All information submitted on this application is accurate to the best of my knowledge. I agree to follow the requirements of the laws, codes and ordinances of the Charter Township of Bangor. I understand an inspector is authorized to inspect the construction until work is completed and a final inspection sticker or certificate of occupancy is issued. I understand it is my responsibility to notify the inspector when the construction is ready for all inspections.

Section 23A of the State Construction Code Act of 1972, Act No. 230 of the Public Acts of 1972, being section 125.1523A of the Michigan Compiled laws, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or a residential structure. Violators of Section 23A are subject to civil fines.

**HOMEOWNER AFFIDAVIT:** I hereby certify the building work described on this permit shall be installed **by myself in my home** which I am living or about to occupy. All work shall be installed in accordance with the Building code and **shall not be enclosed, covered up or put into operation** until it has been **inspected and approved** by the Building Inspector.
